## **RULES OF THE HOLIDAY RECIPE CONTEST**

# § 1

#### **GENERAL PROVISIONS**

- This document (further: "Rules") describes the terms and conditions of the Holiday Recipe Contest (further: "Contest").
- 2. Within the Contest we invite you (further: "Contestant") to share with us a recipe for your favorite winter beverage (further: the "Recipe") in the comment section to a dedicated social media post on (1) Facebook, Instagram (3) Twitter (4) dedicated forum thread https://forums.cdprojektred.com/index.php?forums/community/ (each of the platforms a "Platform"). We will awards prizes (one prize per Platform on which the dedicated posts are published, four (4) prizes in total) to the Contestants chosen based on the creativity and originality of the Recipes.
- 3. The Contest is open for participants all around the world.
- 4. The Contest is organised by us, the company CD PROJEKT S.A., with its registered office in Warsaw, Poland, ul. Jagiellońska 74, 03-301 Warszawa, registered by the District Court for Warsaw in Warsaw, 13<sup>th</sup> Commercial Department of the Polish Court Register, under Polish Court Register number KRS 0000006865, tax identification number NIP 7342867148, statistical number REGON 492707333; share capital of PLN 96,120,000.00, paid up in full (further: "we" or the "Organiser").

#### § 2

## WHO CAN PARTICIPATE?

- 1. You can participate in the Contest if:
  - a. you are at least 18 years on the day of entering the Contest and you have full legal capacity,
    i.e. you can independently enter into legal transactions, including binding contracts, in accordance with your local law, or
  - b. you are between 13 and 18 years on the day of entering the Contest and your parent or guardian reviewed these Rules and approved your participation in the Contest.
- You cannot participate in the Contest if you are an employee of the Organiser or of its affiliates, subsidiaries, manufacturers, sales representatives or advertising agencies, or a member of such employee's immediate family.

# § 3

# WHEN THE CONTEST TAKES PLACE?

- The Contest begins on December 6<sup>th</sup> 2019 and will end on December 13<sup>th</sup> 2019, 5.00 P.M. CET ("Contest Period"). You must submit your Recipe by the end of the Contest Period. Any Recipes submitted outside the Contest Period will not be included in the Contest.
- 2. The winners will be announced within one (1) week from the end of the Contest Period.

#### **§ 4**

#### **HOW TO PARTICIPATE?**

- 1. In order to participate you need to submit a recipe for your favorite winter beverage (the "Recipe") in the comment section to a dedicated social media post on (1) Facebook, (2) Instagram (3) Twitter or (4) a dedicated forum thread at ttps://forums.cdprojektred.com/index.php?forums/community/ (further: "Submission").
- 2. You may make only one Submission containing only one Recipe on the same Platform. Submissions containing multiple Recipes or subsequent Submissions made by a single Contestant to the same Platform will not qualify for the Contest.
- 3. Submissions provided in any other way do not qualify.
- 4. Your Recipe must be appropriate to show to minors.
- The Organiser reserves the right to reject a Submission if it violates the provisions of applicable law, rights of third parties, Contest rules or if the Recipe may be considered racist, xenophobic, sexist, defamatory or otherwise offensive or illegal.

#### § 5

#### **HOW WILL THE WINNERS BE CHOSEN?**

- 1. Winning submissions will be selected by the Contest Committee consisting of the CD PROJEKT RED Community Managers.
- 2. The Contest Committee will choose the winning Recipes based on the creativity and originality of the Recipes.
- 3. The Contest Committee's decisions are final.
- 4. The Contest Committee will awards four (4) prizes in total, one prize per Platform on which the dedicated posts are published.
- 5. The Organiser reserves the right to award other special prizes at its sole discretion.

## § 6

## WHAT ARE THE PRIZES?

- 1. Each winner will receive the prize consisting of a Witcher III: Wild Hunt mug gift set of the retail value of USD 39.00.
- 2. The prizes will be sent by mail to the addresses provided by the winners. The Organiser will cover the prize shipment cost.
- 3. If necessary by applicable law, the Prizes will be supplemented with cash prize equal to the tax due on the prize. The Organiser will deduct the cash prize and will pay the tax due under Polish law.
- 4. The winners will be announced in a public post on each relevant Platform. The Organiser will also contact the winners directly in a private message on the given Platform. Each winner will have seven (7) days to confirm whether he or she accepts the prize and to provide a postal address to which a prize will be sent. If a Contestant fails to contact us within that deadline or refuses to accept the prize, we retain the right to award such prize to another Contestant or to refrain from awarding this particular prize.

# § 7

## **CONTESTANT'S OBLIGATIONS AND DECLARATIONS**

- 1. By sending the Submission in accordance with § 4 above, you (as a Contestant) confirm that you fulfil the requirements set out in the Rules.
- 2. By sending the Submission, you agree that if you win the Contest, the Organiser may use your username or name visible on the given Platform in announcements of the Contest results or in any other promotional materials applicable to the Contest.

  - a. producing copies of your Submission using all techniques;
  - b. distribution and dissemination of your Submission in all channels;
  - c. making your Submission available in a manner allowing any person to access your Submission in a place and at a time selected by them.
- 2. The licence referred to in § 8 point 1 is granted for an indefinite time.

#### § 9

## **PERSONAL DATA**

- 1. Your personal data controller is CD PROJEKT S.A. with its registered seat in Warsaw, Poland, ul. Jagiellońska 74, 03-301 Warszawa.
- 2. Your personal data will be processed for the purpose of carrying out a competition organized by CD PROJEKT, in which you intend to take part, in particular for the purpose of contacting contestants, assessing submissions, awarding prizes and announcing results.
- We respect your privacy rights i.e. the right to access, rectify and delete your data, limit its processing, transfer it, a right not to be a subject to automated decision-making, including profiling, and to object to the processing of your personal data (you will find more details about processing of your personal data in the <u>CD</u> PROJEKT RED Privacy Policy

- 1. The Organiser will not cover any potential costs incurred by the Contestant in connection with the Contest, including entering the Contest, as well as submitting the Recipe and receiving the prize, subject to § 6 above.
- 2. The Organiser informs that the Contest is in no way sponsored, endorsed, administered by or associated with any of the Platforms, i.e. Facebook, Instagram or Twitter.

- 1. The Rules will be governed and construed in accordance with the Polish law.
- 2. The Rules come into force on December 6<sup>th</sup> 2019.
