



(EN) RULES OF THE #WITCHER10THANNIVERSARY FORUM CONTEST

§ 1

GENERAL PROVISIONS

1. This document (further: “**Rules**”) describes the terms and conditions of the #Witcher10thAnniversary Forum contest (further: “**Contest**”).
2. Within the Contest we invite you (further: “**Contestant**”) to show us your inventory - make a photo of your Witcher-themed collection (“**Photo**”) and post it in the comment under the post announcing the Contest on our official Forum (as defined below). The prizes will go to the Contestants with the most creative and original Photos submitted during the Contest.
3. The Contest is open for all persons who are registered members of the official CD PROJEKT RED fan forum, available under the link: <http://forums.cdprojektred.com/> (further: “**Forum**”).
4. The Contest is organised by us, the company CD PROJEKT S.A., with its registered office in Warsaw, Poland, ul. Jagiellońska 74, 03-301 Warszawa, registered by the District Court for Warsaw in Warsaw, 13th Commercial Department of the Polish Court Register, under Polish Court Register number KRS 0000006865, tax identification number NIP 7342867148, statistical number REGON 492707333; share capital of PLN 96,120,000.00, paid up in full (further: “**we**” or the “**Organiser**”).

§ 2

WHO CAN PARTICIPATE?

1. You can participate in the Contest if:
 - a. you are at least 18 years on the day of entering the Contest and you have full legal capacity, i.e. you can independently enter into legal transactions, including binding contracts, in accordance with your local law, or
 - b. you are between 13 and 18 years on the day of entering the Contest and your parent or guardian reviewed these Rules and approved your participation in the Contest, and
 - c. you are a registered member of the Forum, and your account is not blocked.
2. You cannot participate in the Contest if you are an employee of the Organiser or of its affiliates, subsidiaries, manufacturers, sales representatives or advertising agencies; or a member of such employee’s immediate family.

§ 3

WHEN THE CONTEST TAKES PLACE?

1. The Contest begins on October 26, 2017 and will end on November 12, 2017, 23:59 CET (“**Contest Period**”). You must post your Photo by the end of the Contest Period. Any Photos submitted outside the Contest Period will not be included in the Contest.
2. Results will be announced within 14 days after the Contest Period ends.

§ 4

HOW TO PARTICIPATE?

1. In order to participate, make a creative photo of your collection of items connected with the Witcher video games franchise (e.g. game cases, posters, Gwent cards, collectibles, etc.).
2. Post the Photo as a comment under the post announcing the Contest on our official Forum. Alternatively, you may upload the photo to an external hosting platform and embed it in the comment under the Contest post on the



Forum..

3. Submitting Photos requires an active Forum account. Registration on the Forum is free. Submissions on any other platform do not qualify.
4. The Organiser reserves the right to reject a Contestant's submission, if:
 - a. the Photo may be considered racist, xenophobic, sexist, defamatory or otherwise offensive or illegal;
 - b. the Photo violates the Rules of the Forum,
 - c. at the moment of resolving the Contest, the Forum account of the Contestant was blocked.

§ 5

HOW WILL THE WINNERS BE CHOSEN?

1. Winning submissions will be selected by the Contest Committee consisting of the Community Team of the Organiser.
2. The Contest Committee will choose the winning Photos based on creativity and originality.
3. The Contest Committee's decision is final.
4. The Contest Committee will award in total up to 14 Contestants with the best Photos submitted during the Contest Period in the following tiers:
 - a. First Place – 1 Contestant;
 - b. Second Place – up to 3 Contestants;
 - c. Third Place – up to 5 Contestants;
 - d. Honorable Mentions – up to 5 Contestants.
5. The Organiser reserves the right to award other special prizes at its sole discretion.
6. For avoidance of doubt, the prize pool described in §6 is common for all Contestants, irrespective of the language version of the Rules displayed to the Contestant.

§ 6

d. **Honorable Mentions** – tiny bundle containing:

- The Witcher 3 Soundtrack
- Witcher's medallion
- The Witcher 3: Wild Hunt – PC Steelbook (Skellige)

having an overall retail value of PLN 105.00;

2. The prizes will be sent by mail, to the addresses provided by the winners. The Organiser will cover the prize shipment cost.
3. All the winners will be informed about the Contest results by a private message on the Forum. Upon receiving such information, each winner will have seven (7) days to declare, whether he or she accepts the prize and to provide a postal address to which a prize will be sent. If a Contestant fails to reply to the message within that deadline or refuses to accept the prize, we retain the right to award such prize to another Contestant or to refrain from awarding this particular prize.

§ 7

CONTESTANT'S OBLIGATIONS AND DECLARATIONS

1. By sending the submission in accordance with § 4 above, you (as a Contestant) confirm that you fulfil the requirements set out in the Rules.
2. By sending the submission, you agree that if you win the Contest, the Organiser may use your Forum username in announcements of the Contest results or in any other promotional materials applicable to the Contest.

§ 8

COPYRIGHT

1. By posting your submission, you (the Contestant) grant us (the Organiser) a non-exclusive, worldwide, non-transferable, royalty-free licence to use the Photo for the purpose of the Contest, including providing the Photo to the Contest Committee members. This licence covers the following forms of exploitation:
 - a. producing copies of the Photo using magnetic recording, digital techniques, and by means of any computer systems,
 - b. putting the copies of the Photo into circulation or lending the same,
 - c. making the Photo available to the Contest Committee members or to other persons involved in the Contest in a manner allowing them to access the Photo in a place and at a time selected by them.
2. You (the Contestant) grant us (the Organiser) a non-exclusive, worldwide, royalty-free license to use the Photo by publishing the Photo in announcements of the Contest results or in any other promotional materials applicable to the Contest. This licence covers the following forms of exploitation:
 - a. producing copies of the Photo using magnetic recording, digital techniques, and by means of any computer systems,



- b. putting the copies of the Photo into circulation or lending the same,
 - c. public performing, retransmitting, broadcasting and rebroadcasting the Photo, as well as making the Photo available to the public in a manner allowing individuals to access the Photo in a place and at a time selected by them.
3. In case the Contestant will not be awarded until by the results announcement day referred to in § 3 point 2 above, or will not accept the prize within the term referred to in § 6 point 3 above, the licence referred to in § 8 point 2 will terminate immediately.
 4. Licences referred to in § 8 points 1, 2 are granted for an indefinite time.

§ 9

PERSONAL DATA

1. Contestant's personal data (Forum username and – in case of the winners – postal address) will be gathered and processed by the Organiser solely for the purpose of carrying out the Contest, and in accordance with the Polish Personal Data Protection Act of August 29, 1997 (Journal of Laws 1997 no. 133, item 883, as amended). Submission of personal data by the Contestant is voluntary, however necessary for participation in the Contest.
2. The Organiser protects the Contestants' personal data in accordance with the Personal Data Protection Act, in particular the Organiser enables the Contestants to exercise their right to access, correct as well as to request deletion of their data.

§ 10

INDEMNITY

The Organiser will not cover any costs incurred by the Contestant in connection with the Contest, including entering the Contest, submitting the Photo and receiving the prize, subject to § 6 above.

§ 11

FINAL PROVISIONS

1. The Rules are published in the following language versions: English, Polish and Russian.
2. The Rules will be governed and construed in accordance with the Polish law.
3. The Rules come into force on October 26, 2017.
